

CARNE y ARENA COVID-19 Safety Protocols

CARNE y ARENA has implemented extensive safety measures to protect against COVID-19. To learn more, please read the safety protocols.

OVERVIEW

In light of the global pandemic caused by the spread of COVID-19 and in an effort to conduct CARNE y ARENA in the safest way possible, the CARNE y ARENA team has developed the following COVID-19 safety protocols.

No singular element of this protocol establishes a safe environment. The CARNE y ARENA staff will ensure that each element of the protocol is systematically implemented, so that an undue burden is not placed onto a singular pillar of precaution, and every participant is able to participate in the full experience designed by the artist.

TESTING

All CARNE y ARENA staff members have been tested for COVID-19 prior to starting employment and are tested every three weeks.

SOCIAL DISTANCING & ENGINEERING CONTROLS

The CARNE y ARENA facility has been designed with safety in mind. The distinct spaces have been designed to ensure as much separation as possible, whether through patron flow or physical barriers.

All employees and patrons will maintain a social distance of at least 6 feet whenever possible. Staff members and patrons will all take additional precautions such as wearing masks and temperature checks.

The air management system in the CARNE y ARENA installation has been custom designed to ensure appropriate ventilation. The system is equipped with 4 germicidal UV-C (254nm) ozone free 25watts lamps in the air ducts, which have been shown to destroy the outer protein coating of the SARS-Coronavirus, UV-C radiation may also be effective in inactivating the SARS-CoV-2 virus. This technology also kills bacteria, mold, and other biological contaminants. The air management system will run continuously while the exhibit is in use and be fully sanitized nightly.

PERSONAL PROTECTIVE EQUIPMENT

Anyone entering the exhibition space will be required to wear a mask covering their nose and mouth. Bandanas and masks with vents will not be permitted. If someone requesting entry does not have a mask one will be provided for them.

Staff members will change their masks every four hours.

HEALTH MONITORING AND SCREENING

All staff members, patrons, and anyone else entering the exhibit space will be required to go through a health screening, including a symptoms questionnaire and temperature check. If someone answers yes to a symptoms question or displays a temperature greater than 100.4 degrees Fahrenheit they will be informed that they do not meet the current admission criteria for the exhibit.

CLEANING & SANITATION

All high touch surfaces will be disinfected at the close of each day. The entire exhibition space will be treated with an ozone cleaning system every night.

HYGIENE

Patrons will be asked to wash their hands or use a hand sanitizer with greater than 60% ethanol or 70% isopropanol upon arrival. All staff members will be required to wash their hands or use hand sanitizer in between interactions with patrons.
